White Diamond Gutter Guards manufactures a residential gutter guard and warrants the material will not rust or separate when installed correctly in normal area's weather conditions. White Diamond GG is fabricated from mill finished aluminum and stainless-steel screen. White Diamond GG reserves the right to change this warranty at any time, but all warranties in effect at the time of purchase will not be affected by any changes and will remain in effect until their expiration. White Diamond GG is a brand name owned by Artesian Home Products, Loomis CA.

White Diamond GG's Product Warranty

White Diamond GG warrants to you a 20-year transferable warranty from the original date of purchase, when installed in accordance with our specifications, that White Diamond GG is free from defects in material and workmanship in the course of manufacture under conditions of ordinary wear. This warranty is limited to the terms and conditions, exclusions and limitations, requirements and legal rights stated in this warranty. This warranty covers only genuine White Diamond GG's products with installation procedure DGG-R5.

Conditions

We reserve the right to discontinue or change any design or color of any of our products at any time without notice or liability. If, for any reason, the White Diamond GG type originally installed is no longer available from us at the time you make a warranty claim, we may substitute another product determined by us to be of comparable quality and price.

There are no warranties on White Diamond GG products other than as set forth in this warranty. We are not liable to you for a breach of any other written or oral express warranties, such as those, if any, given to you by installers, dealers, contractors, applicators, or distributors of White Diamond GG products. Effective December 18, 2015.

Due to normal weathering, replacement product may differ in gloss or color from the product originally installed. We exclude and are not responsible for any consequential or incidental damages arising out of any breach of this expressed warranty, or any other oral, written or implied warranty that may apply to your purchase, as it relates to our gutter guard. This is your exclusive warranty and is in lieu of all other warranties, express or implied, including but not limited to implied warranties of merchantability and fitness for a particular purpose.

This warranty gives you specific legal rights. You may also have other rights which vary from state to state. Some states do not allow the exclusion or limitation of incidental or consequential damages, and some states do not allow limitations on how long an implied warranty lasts, so the above limitation or exclusion may not apply to you. The obligation under this warranty will in no event exceed the purchase price of the originally installed Product found to be defective. In the event that we choose to replace the gutter guard, we will only be responsible for providing material and not the cost of labor to install or shipping costs.

White Diamond GG is designed to be self-cleaning, and in most cases, rainfall alone is sufficient to keep it clean, but there may be some instances where cleaning/maintenance will be required by the homeowner. We recommend occasional homeowner cleaning and maintenance inspection of the gutter system.

EXCLUSIONS/LIMITATIONS

This warranty does not cover -

- Harmful chemical exposure
- Product being used for unintended purposes or in an inappropriate manner
- Panel removal
- Excessive heat
- Mold or mildew accumulation
- Contact with dissimilar materials
- Damage caused by acts of God, including hurricanes, lightning tornados, thunderstorms, windstorms, hail, etc.
- Failure to perform routine maintenance
- Damage or performance failures due to improper installation
- Vandalism
- Alterations from original installation
- Damage caused by roof structure or gutters settling or distortion
- Natural wear caused by weather or acid rain or other caustic environmental conditions - Impact of foreign objects
- Products that have been painted or whose surface has been altered in any fashion - Fire damage
- Changes in surface color resulting from chalking, fading, soiling or staining due to exposure to elements - Deterioration due to air pollution
- Mesh clogging due to tree sap, paint, tar, leaching roof oils, bird or insect droppings, or other organic accumulations
